1. Meeting started at approximately 6:03 pm.
 2. The January 7, 2025 Parks Board meeting minutes were approved.
 3. Citizens Comments:
 - a. Amy Rider noted her efforts to address evasive vegetation within 5-ft of the trail pavement edge along the Cedar Creek Greenway since her last presentation to the Parks Board in September. She has contacted various entities for support and is asking for the MJ Parks Department for assistance to maintain the greenways once the improvements are completed. Rocky noted he is supportive of her interest and that he would follow-up with her on this matter.
 4. Special Presentations:
 - a. Aaron Kim of Boy Scout troop #911 is pursuing a project to earn Eagle Scout status. He is proposing a giant chessboard (10-ft +/- square) to be located near the Gaga pit with applicably sized-chess pieces kept at the community center. He has started a GoFundMe website to raise funds. It was discussed this is an ambitious endeavor and that maybe a more traditional chess table is reasonable. The Parks Board unanimously voted to

accept this general proposal with the understanding the scope may change and to work with the Parks Department on the details.

5. Park Director's Report:

- a. See attachment for Parks Director notes dated March 4, 2025 and reviewed in the meeting. Various items of note outlined below.
- b. Rocky noted that American Legion 281 is asking permission to install a Blackhawk helicopter at the City clock tower park. After discussion, the Parks Board unanimously voted to approve this proposal.
- c. Rocky noted the Pickleball committee is looking to make program changes with adjustments to the age groups and playing levels.
- d. Discussed that some class leaders using the community center are charging participants to attend. The City does not currently charge class leaders for the room space to encourage them to offer the classes as a community benefit. However, this does not seem fair to class leaders that do not charge. Options discussed: (1) Charge for the room space, (2) charge per participant, or (3) Parks Department to determine on a case-by-case basis. It was noted the City's room rate charges are nominal and should not be a hindrance for the class to cover. After discussion, the Parks Board approved recommending the Parks Department charge for the room to the class leader at the current City of Mt. Juliet room rate if the class leader charges their participants. Otherwise, the current policy of not charging for the room to classes that are free to participate would continue.
- e. Concrete pads for the Buddy Bridge at the Sellers Dog Park should happen in the spring.
- f. The Parks Department is fixing a water leak at Hamilton-Densen Park.

8. Friends of the Mt. Juliet Parks 501c

- a. It was reported the 501c bank balance currently sits at \$13,958.13.
- b. The Friends of the Mt. Juliet Parks group is donating \$2,000 for two new Pickleball nets.
- c. A motion was made and approved to donate \$100 to Aaron Kim for his proposed Eagle Scout project.

Parks Director Rocky Lee welcomed everyone and explained the need to form the Pickleball Committee.

Discussion was held on where the greater need is.

Per Parks Director Rocky Lee, all pickleball questions/concerns/complaints/etc. will be brought to Assistant Parks Director Melinda Troutman, and all Parks Staff are considered the Ambassadors for Charlie Daniels Park. The Ambassadors for Mundy Park are Kit Magalei, Terri Atwood, and Sean Donovan.

Items discussed:

- Eliminate, or move, Picklesize from Friday schedule
- The need for more afternoon and evening court time
- Summer pickleball camp for kids
- The possibility of creating a league team
- Would we want to limit (or) increase the number of pickleball tournaments per year / possibly use 20 courts (10 at Charlie Daniels and 10 at Mundy Park) divided by skillset or age group
- Hosting a Pickleball Palooza using 12 courts at \$20 entry fee per player with a free t-shirt
- Picklesize is currently maxed at 22 players. We could possibly increase the size to 30, and keep the winning points at 7
- Enforcing a "winners" and "losers" box
- Giving the Intermediate Friday class an extra hour (11:30am – 3:00pm)
- Adding pickleball rules onto the gymnasium wall
- Establishing a Wilson County "residents only" rule at Mundy Park

Rocky mentioned that everything discussed in today's meeting will be presented at the Parks Board meeting on Tuesday, March 4th, where all the rules will be established and put into action.

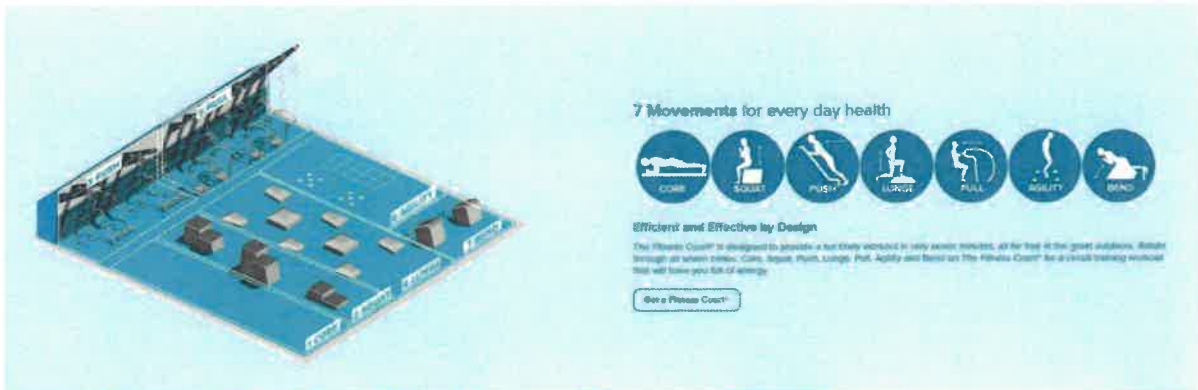
Rocky then wanted to begin today's meeting with PickleCIZE.

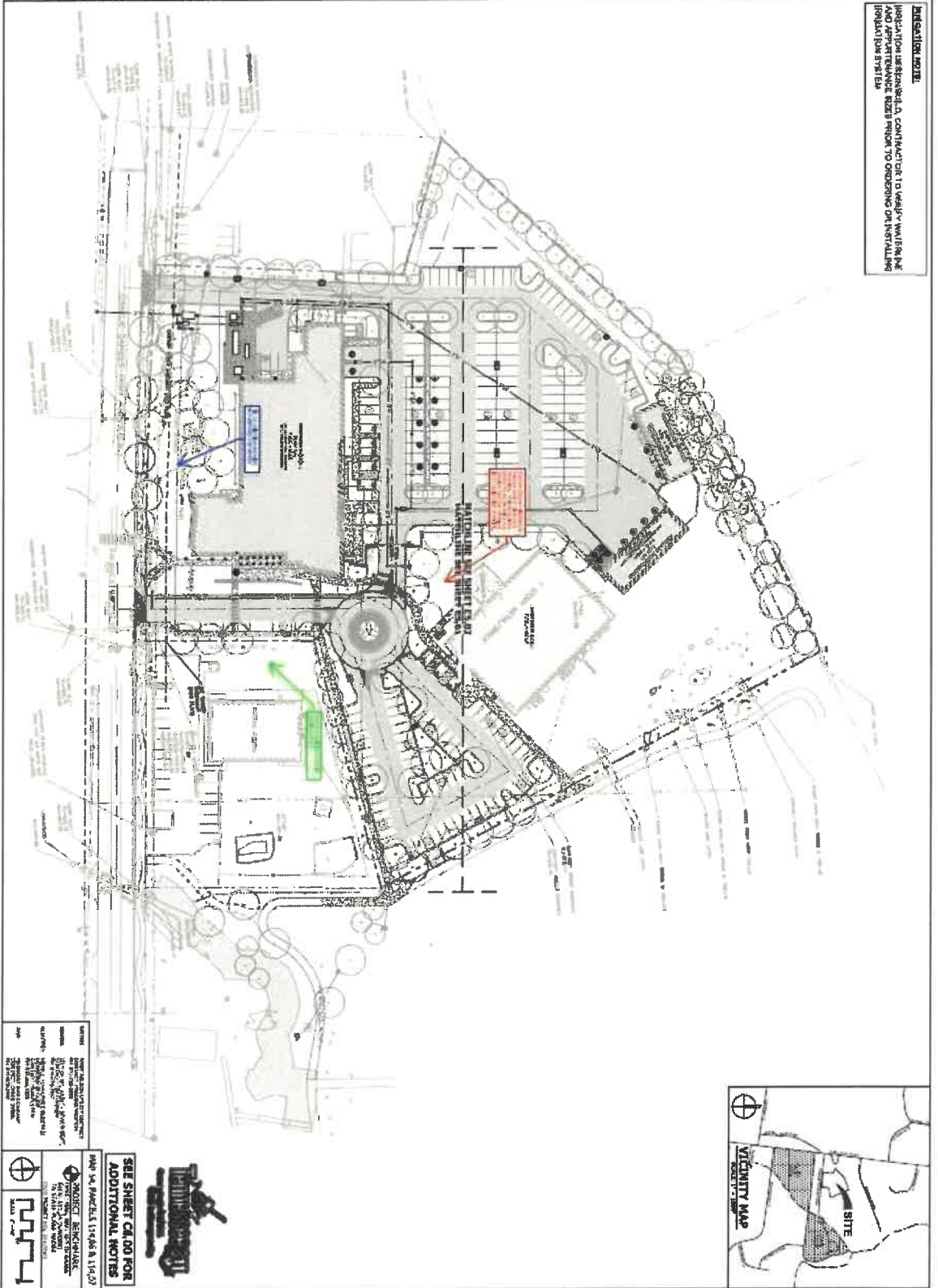

1. Funding Needs

The committee emphasized the importance of obtaining funding and approval from the Board of Commissioners (BOC) to proceed with the design and construction of a community pool and gym. Current budget allocations stand at zero.

2. Cost Estimates

- A professional estimate for the initial pool design is quoted at \$32,000, refundable upon winning the construction bid.

- The estimated cost to build a commercial indoor pool ranges from \$1.5 to \$2 million, while Phoenix Construction has provided a quote of \$10 million for the complete facility, not including an additional \$750,000 for a parking lot and \$1.5 to \$2 million for the pool.

- A practical plan is required to fit within the estimated budget of \$14 million, addressing community needs for the pool, gym, and sports courts.

3. Facility Design Features

The preliminary pool design includes:

- A zero-entry area
- A deeper section for water aerobics
- Six lap lanes

4. Citizen Feedback

Citizens presented their concerns and needs, including:

- Demand for an 8-lane, 25-yard short course pool to support over 1,000 youth in swimming activities.
- Importance of effective facility construction to avoid constant renovations, as families currently travel to Lebanon for swimming.
- Advocacy for proper feasibility studies and funding transparency.
- Concerns regarding the proposed pool for the Providence Homeowners Association and community growth sustainability.
- Support for conducting a feasibility study given overcrowding at local facilities, such as the YMCA.
- Focus on resources for specialized swimming programs, particularly for people with special needs.
- Questions about the budget for new facilities and the need for a thoughtful design to meet community needs.

5. Project Development

Rocky discussed the development of a wish list for the park project, informed by the community input from town hall meetings. He highlighted the recent leadership change involving Commissioner Justice and noted that the experts involved are volunteers working with Phoenix Builders to assess realistic construction plans within a funding range of \$11 - \$14 million.

6. Emphasis on Recreational Needs

Rocky advocated for a new pool that meets diverse community requirements, moving beyond just competitive swimming. He noted past issues with the YMCA competition pool that stemmed from financial constraints and urged the importance of supporting recreational programs. A smaller, affordable pool was identified as necessary, amidst frustrations regarding the

community's demand for immediate solutions and willingness to increase property taxes to fund the project.

7. Focus on Safety and Community Service

The committee stressed the necessity of creating a facility that accommodates recreational activities for families and ensures child safety while remaining within budget and addressing community expectations.

8. Additional Remarks

- Rocky mentioned the city's low property tax rate compared to nearby areas and addressed concerns from Commissioner Jennifer Milele regarding project timelines and benefits for families and competitive swimmers.
- Facilities such as weight rooms were excluded to prevent competition with existing gyms as directed by the Board of Commissioners.
- Preliminary grading work is already underway at the project location (Clemmons Rd.) without incurring additional taxpayer funding.

9. Open Comment(s) Conclusion

After each citizen had the opportunity to comment, they were asked to either move to the back of the meeting room or leave quietly while a Committee Only Meeting was held.

10. Advisors and Committee Members Meeting

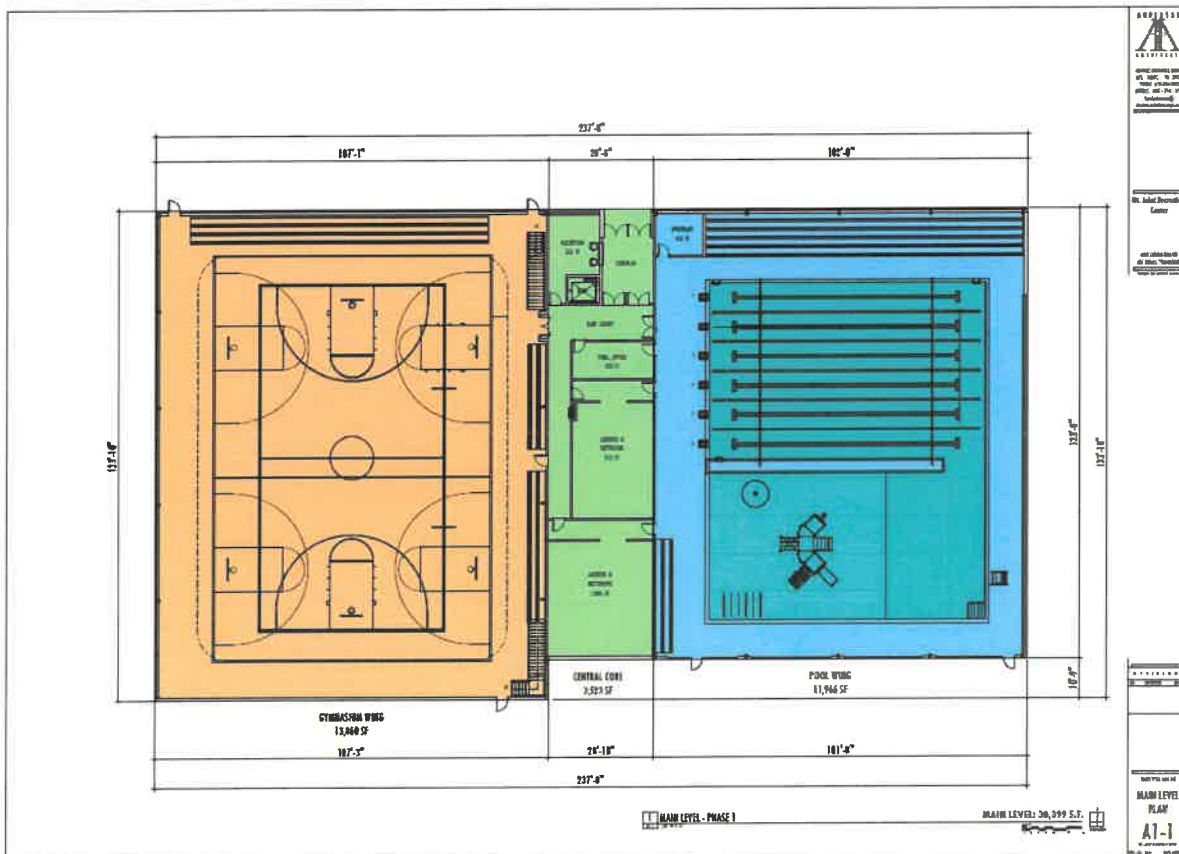
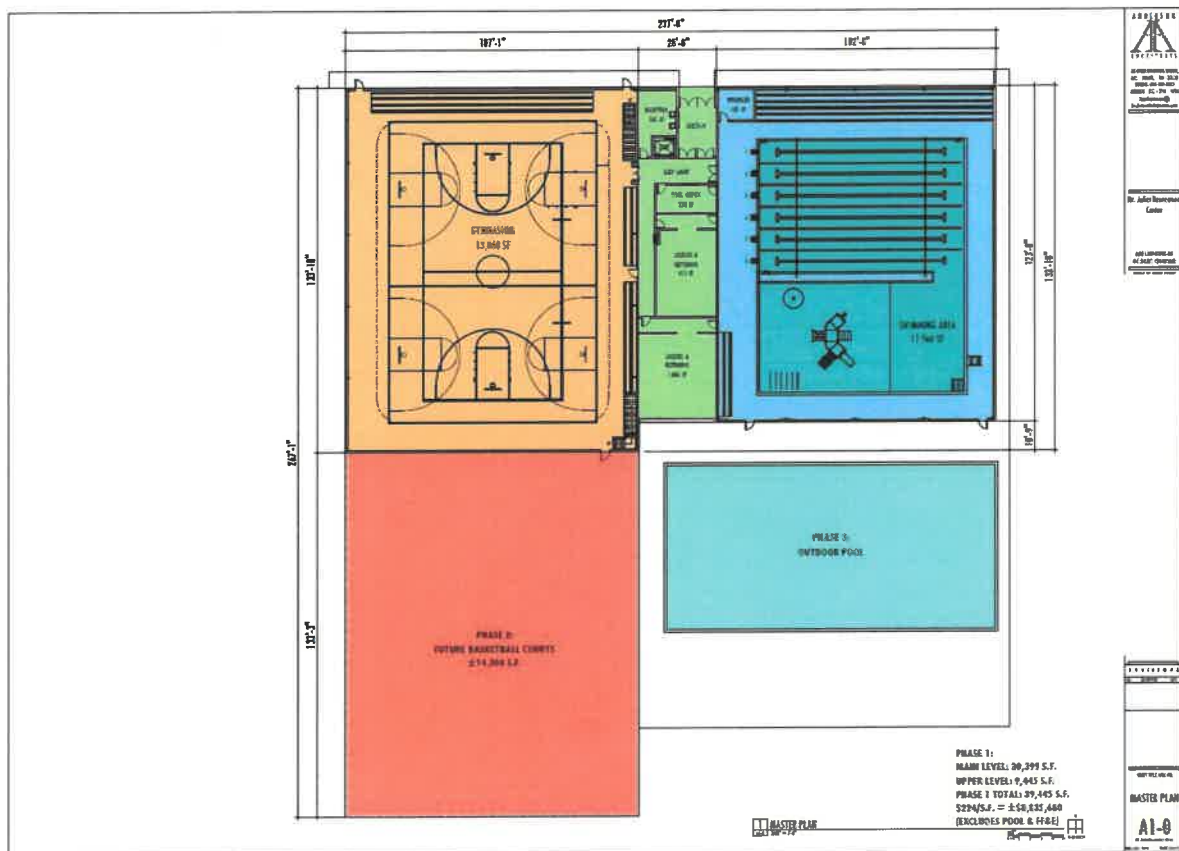
The committee members and Advisors—Rob Porter, Chip Bailey, Shawn Donovan, AnneMarie Wheeler, Rachel Walstron-Crosslin, and Keith Canfield—unanimously agreed to proceed with a plan that fits within our budget. They reviewed the current drawings and confirmed that six pickleball courts would fit into the basketball court area. Additionally, they approved the proposed HVAC adjustments, the inclusion of storage rooms on the second floor, and the addition of a 5-foot dive-in area alongside the lap lanes in the pool.

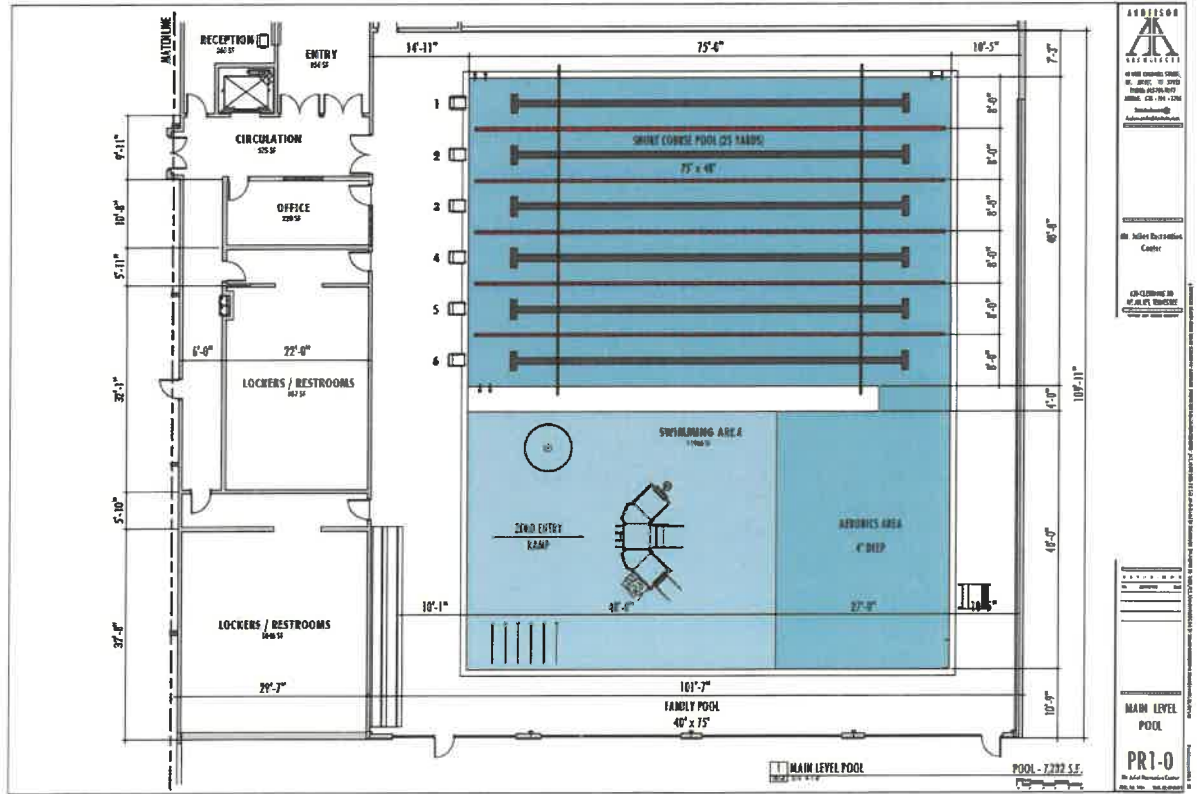
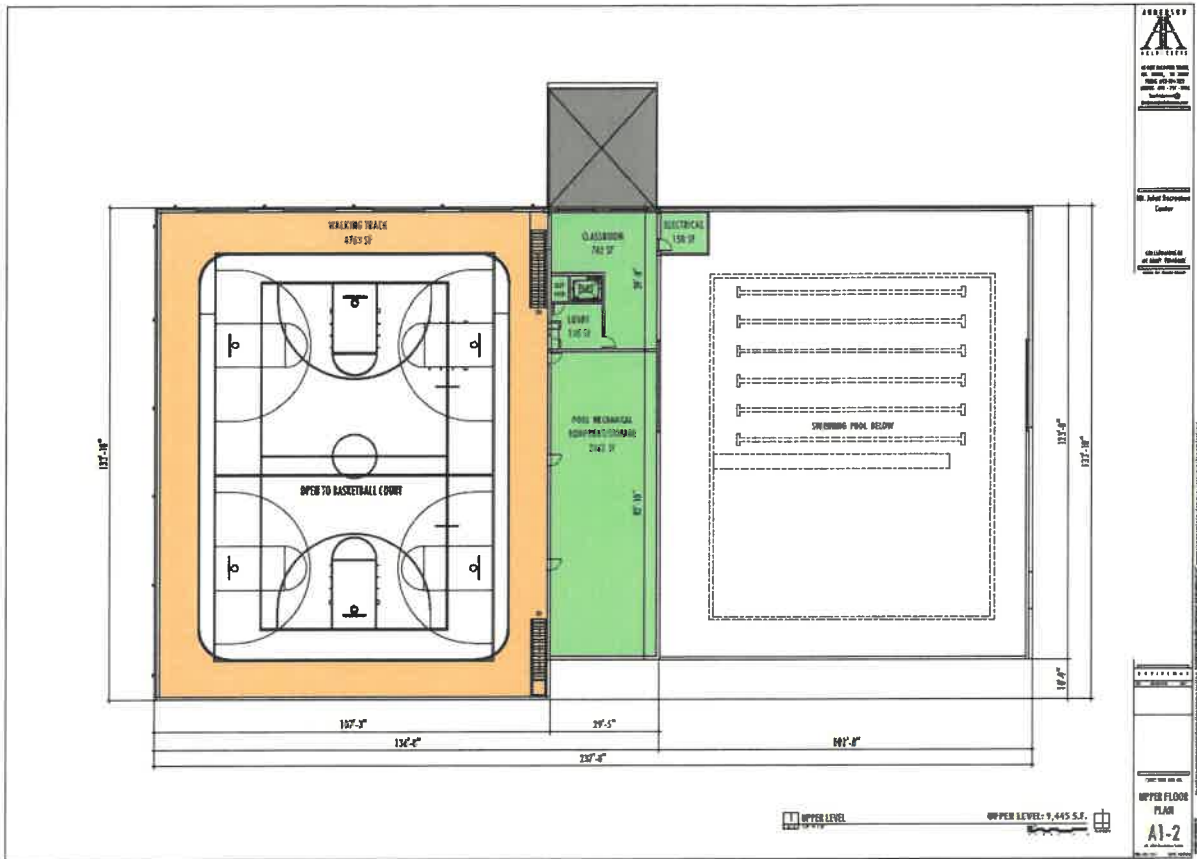

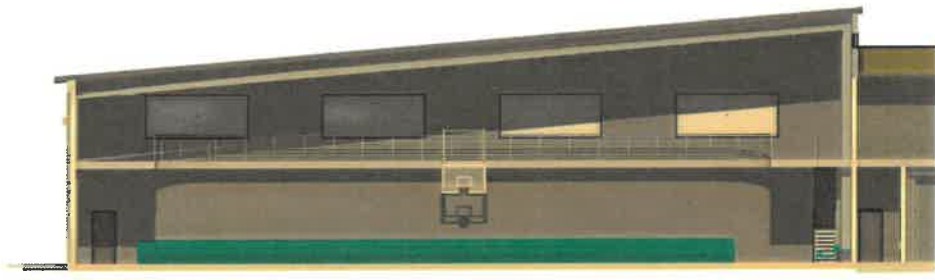




BASKETBALL PERSPECTIVE

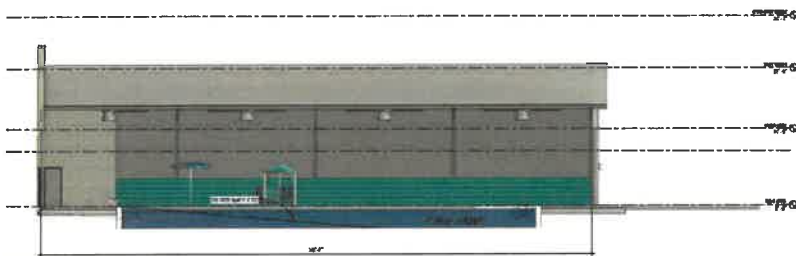
SECTION THROUGH BASKETBALL COURT



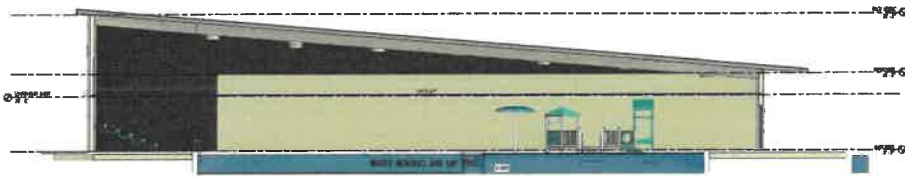

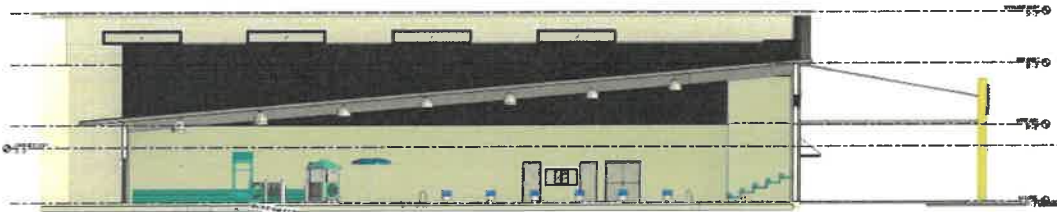

WEST SECTION THROUGH AEROBICS POOL



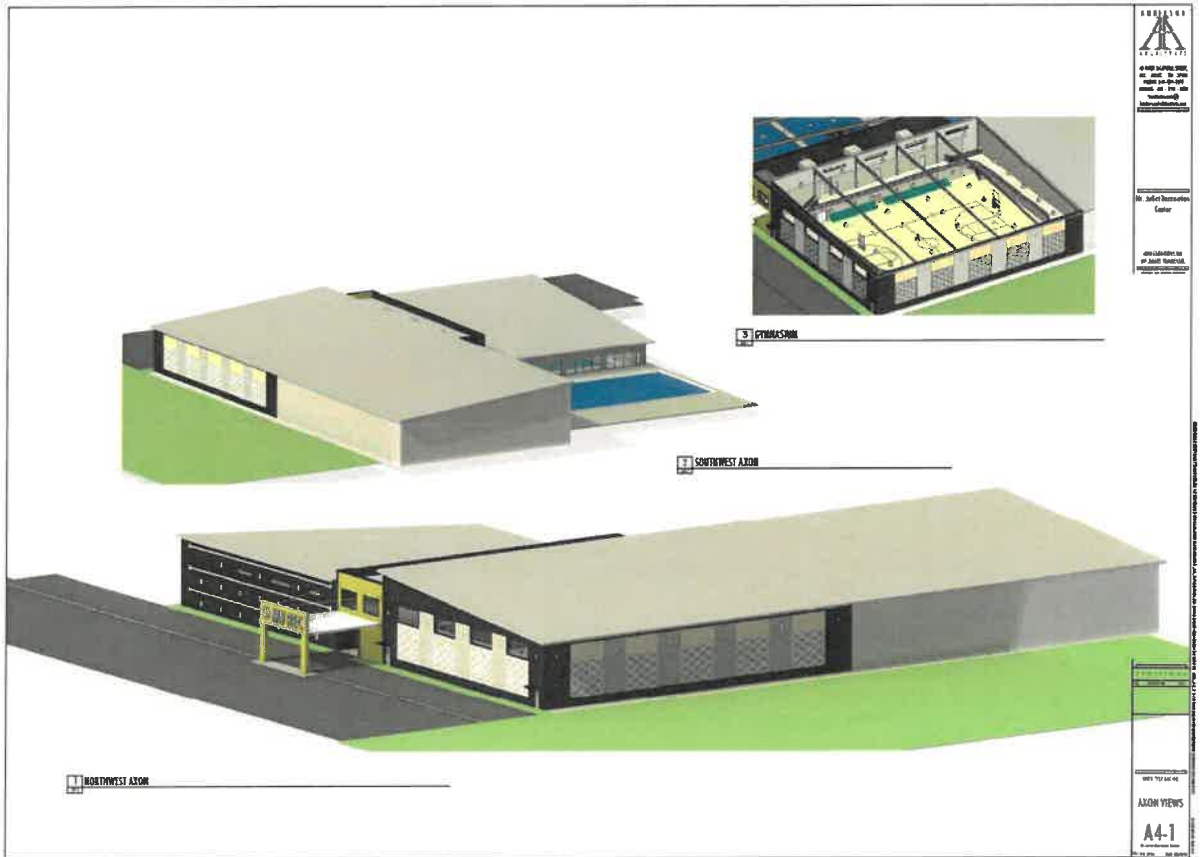
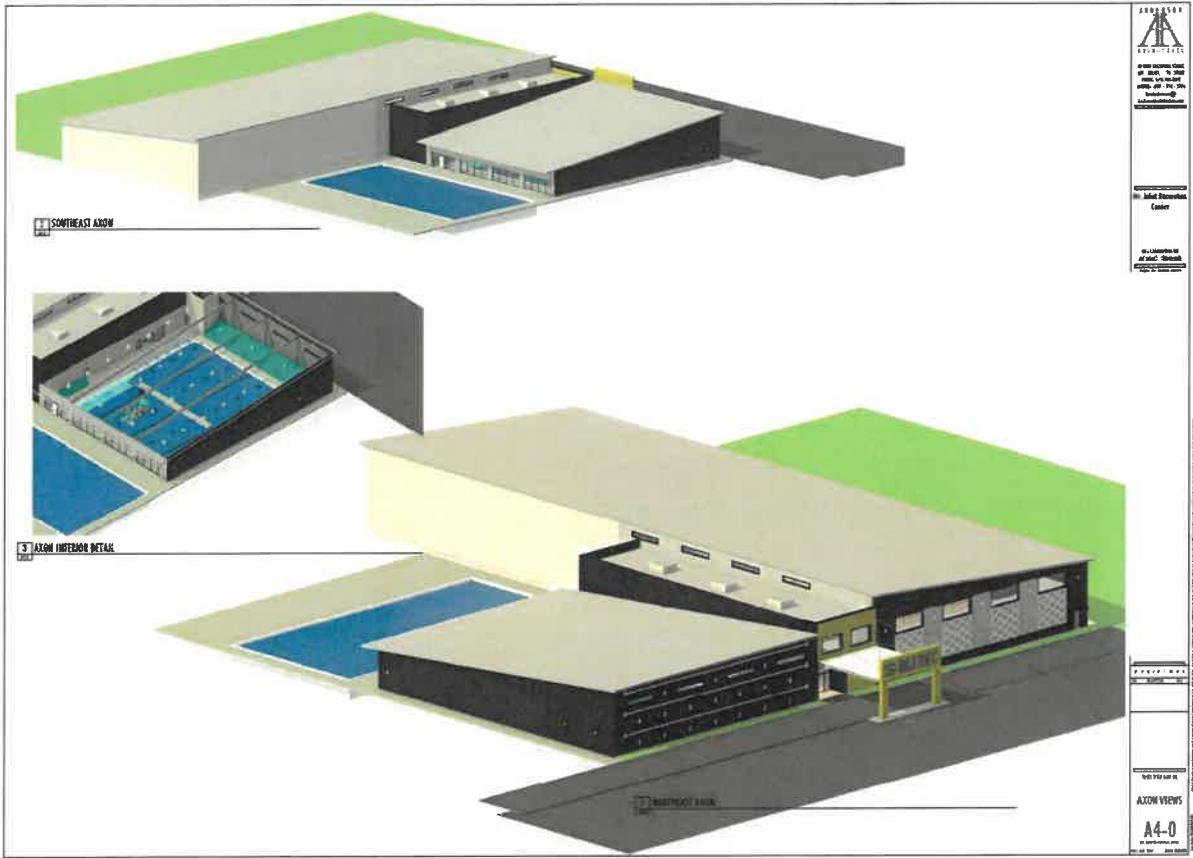
