- 1. Meeting started at approximately 6:02 pm.
- 2. The March 4, 2025 Parks Board meeting minutes were approved.
- 3. Citizens Comments:
 - a. Amy Rider updated her activities in the past months on the goals to address evasive vegetation within 5-ft of the trail pavement edge along the Cedar Creek Greenway. She noted that the Tuscan Gardens subdivision approved her plan and that a site walk was being scheduled with the MJ Parks Department next week. She has started coordinating with TDEC on applicable permits. She also noted that an organization reached out to her and is willing to donate 500 trees (four different species) and whether the Parks Department could use them? Rocky noted that some of these could be used to replace some trees along the Town Center Trail that have died since they were first planted.
- 4. Special Presentations:
 - a. Jonathan Parkhurst is working on his Eagle scout badge and presented his project to install a wood-framed donation box in the lobby of the CDP Community Center. These would be collected and donated to the Salvation Army, Health Care, or others on a rotating basis. Jonathan will be preparing flyers and other signage to promote its

existence and use. After discussion, it was unanimously approved by the Parks Board. Jonathan stated he would be installing the donation box later tonight.

5. Park Director's Report:

- a. See attachment for Parks Director notes dated May 6, 2025, and reviewed in the meeting. Various items of note outlined below.
- b. An all-inclusive merry-go-round will be installed by a non-profit group to be located near the Squirrel Run play equipment.
- c. Rocky noted there was some discussion on the proposed senior citizens center building and the need for Commissioner space. No decisions have been made and that the Center's renovation bids were proceeding.
- d. Rocky noted that due to City budget shortfalls, there is a hiring freeze in effect.
- e. Rocky noted that the new recreation center project was presented the Board of Commissioners last Monday. Pool will have six swim lanes. Building cost is running between \$7.5M and \$10.0M
- f. <u>Splash Pad</u>: Rocky noted that they see a lot of out-of-county buses arrive which overwhelms the facility and causes long wait times. Rocky asked for the Board's input on how to control this concern. After discussion, a consensus was made to limit usage of Ava Splash Pad to only entities based in Wilson County. This would primarily be enforced on the large day-care or summer-camp type out-of-county buses and that smaller groups or families could be tolerated and not turned away. The Splash Pad attendees would monitor the situation and call the personnel in the CDP community center to police the situation. Also recommended signage be installed making it clear the facility is intended for Wilson County residents. Also, swimwear is required to avoid issues with balancing the water pH levels.
- g. An Equalization Basin is being installed at the corner of Old Lebanon Dirt Road.
- h. Noted upcoming July 4th firework event at Circle Ranch. More activities are being planned to fill the time until the fireworks occur including a car show.
- i. Noted a Barry Wilmore Day (astronaut) at 11 am, June 28 at CDP. Barry will be speaking and will be presented various acknowledgements such as a quilt.
- j. The parking lot at Robinson Park is scheduled for paving.

- a. The two new pickleball nets, paid by the Friends of the Mt. Juliet Parks group, is being used and was well received by the group.

Robinson Park: The walking trail has been paved, and they're in the process of paving the parking lot.

Hamilton-Densen Park: We're working with Cunningham Rec to get us a quote on installing sunshades over the play equipment.

Eagle Park: Lisa Stine has requested to maintain the landscaping in the flowerbed in honor of her son, Hunter. She is gathering ideas and will present them to us soon.

Park Greenways: The Mundy Crew has sealed the wooden boardwalks on the greenways.

- Cedar Creek Greenway: Approximately 30 volunteers from Keller Williams will be painting the fence along the trail on May 8th for their Annual Community Give Back Day.
- Cedar Creek Greenway Phase 2: Phase 2 will connect CDP to Lebanon Rd pending TDOT approval. It is 20% complete with pre-construction activity.
- Town Center Trail: Phase 3 will extend from S. Greenhill Rd to MJ Elementary and is 75% complete with preconstruction activity. Phase 4 received approval to install a greenway trail from the Train Station east to Clemmons Rd, following alongside Clemmons Rd to the Lynwood Station site.
