Details:

On 5/1/2024 at approximately 1635 hours, detectives with the Mt. Juliet Police Department's Crime Suppression Unit conducted an on-site alcohol compliance check at Painturo's, (12910 Lebanon Road).

Utilizing an adult underage confidential informant (CI); detectives provided the CI with \$10.00 of Official

Advance Funds (OAF) and briefed the CI about the operation. A short time later, the CI entered Painturo's and was able to successfully purchase a Bud Light for \$3.50. The CI's ID was checked but a purchase was still made as observed by audio/video recording. Once the transaction was complete, the CI exited the restaurant and described the offender to detectives. The CI stated the offender was a short hispanic female, with long black hair and a pinkish shirt. The receipt also reflected the name Marley D.

After speaking with the CI and gathering all information, Detective Hoppe and I entered the establishment and made contact with Marim Tawadrous () at the front register who matched the description. I spoke to her about the incident as the manager Cassidy Decarlo came to front counter. I advised Cassidy of the incident, and she stated that Marim checked the ID, but Cassidy was in fact the person that served the CI the Bud Light. Cassidy was subsequently issued a misdemeanor citation for violation of TCA 57-5-301, Sales to minors or intoxicated persons prohibited. Her court date was set for Monday, August 19th, 2024, in Wilson County General Sessions Court. I advised Cassidy of the court process and she stated she understood.
