- The Alcoholic Beverage Board meets on the 2nd Tuesday of each month (as needed) at 6:30 p.m. (CST) in the Commission Chambers at City Hall, located at 2425 N Mt. Juliet Rd., Mount Juliet, TN 37122.
- Applications are due no later than 4:30 p.m. (CST) 15 days preceding each meeting. All questions on the application must be filled in completely and answered. Failure to do so will only delay the process. If a question does not apply to your business, insert "n/a" (not applicable) into that space. The Alcoholic Beverage Board will not approve any incomplete applications.
- Application must be notarized.
- After your required paperwork has been properly submitted, you will be placed on the Alcoholic Beverage Board agenda for consideration. Your appearance is mandatory.
- A \$250.00 application fee is due to the City of Mt. Juliet when the application is submitted. Additionally, business applicants must remit a prorated privilege tax payment with their submission. The prorated privilege tax is located on page 2 for your reference.
- Please note that all questions must be answered on the application. Failure to do so will only delay the
 process. The Alcoholic Beverage Board will not approve any incomplete applications.

A prorated share of the Annual Beer Privilege tax of \$100 is imposed on the business selling, distributing, storing, or manufacturing beer in this state effective January 1, 1994 and each successive January 1. Any holder of a beer permit issued after January 1, 1994 shall pay a pro rata portion of this annual tax when the permit is issued. (Please see meeting schedule below.)

A \$100.00 yearly renewal fee is due every January 1st.

Your completed application must be submitted at least fifteen (15) days prior to the Alcoholic Beverage Board meeting at which it is to be considered. Applications received after the deadline will be placed on the following month's meeting. (5) Hotels/Motels

- a. Subsections (1) through (4) of this section shall not apply to hotels/motels. Hotels/motels will be eligible for beer permits so long as: a) the hotel/motel has at least 100 guest rooms intended to be used for overnight stays that contain both individual bedding and individual access to sanitary sewer; and b) the hotel/motel serves only hotel patrons and their guests. Subject to rules and regulations adopted by a hotel/motel license pursuant to this article, the premises where such beer may be consumed includes the entirety of the hotel/motel grounds. Beer sold pursuant to such a hotel/motel permit shall not be permitted to be consumed off of the hotel/motel's premises in any instance. In addition to other penalties set forth in article III, chapter 4 of this Code, a hotel/motel beer permit holder shall likewise be penalized for violations of this subsection (5).
 - b. The licensed permit holder for the hotel/motel shall be the general manager of the hotel/motel or person of equivalent position. Each new general manager or person of equivalent position must meet all criterion in this chapter for the holder of a beer permit.
