### Details:

On 05/01/2024 at approximately 1100 hours, detectives with the Mt. Juliet Police Department's Crime

Suppression Unit conducted an on-site alcohol compliance check at NOBU Hibachi Restaurant, (401 S. Mt. Juliet Road #155).

Utilizing an adult underage confidential informant (CI); detectives provided the CI with \$10.00 of Official Advance Funds (OAF) and briefed the CI about the operation. A short time later, the CI entered NOBU and was able to successfully purchase a bottled Bud Light for \$4.94. The CI's ID was checked but a purchase was still made as observed by audio/video recording. Once the transaction was complete, the CI exited the restaurant and described the offender (Leo Cordoza) to detectives. The CI stated the offender was an Asian male with a bald head and NOBU work attire. The receipt also reflected the name Leo.

After speaking with the CI and gathering all information, Detective Hoppe and I entered the establishment and made contact with Leo. Leo was subsequently issued a misdemeanor citation for violation of TCA 57-5-301 Sales to minors or intoxicated persons prohibited. His court date was set for Monday, August 19<sup>th</sup>, 2024, in Wilson County General Sessions Court. I advised Leo of the court process and he stated he understood.
