City Attorney Burnett read two amendments proposed by Finance Director Dana Hire on behalf of the Police Department (PD).

The first amendment addressed two vehicles that were recently involved in accidents, and the department had just received insurance reimbursement for them.

The net effect on the fund balance will remain zero, but the amendment increases the Insurance Recovery Revenue and the Transportation Equipment line to allow the PD to use those funds to purchase replacement vehicles.

The proposed changes are as follows:

110-36350 Insurance Recoveries:

From \$80,500

To \$157,704

110-42100-944 Transportation Equipment:

From \$617,000

To \$694,204

The amounts received for the two vehicles were \$19,778.25 and \$57,425.75, totaling \$77,204.
