This application for the certificate of compliance may be amended at the discretion of the City of Mt. Juliet Alcoholic Beverage Board. The information in the application shall be verified by oath of the applicant. If the applicant is a partnership or a corporation, the application shall be verified by oath of each partner, or by the corporation's authorized officer.*
