Details:

On 05/01/2024 at approximately 1212 hours, detectives with the Mt. Juliet Police Department's Crime

Suppression Unit conducted an on-site alcohol compliance check at Red Lobster, (401 S. Mt. Juliet Road #120).

Utilizing an adult underage confidential informant (CI); detectives provided the CI with \$10.00 of Official Advance Funds (OAF) and briefed the CI about the operation. A short time later, the CI entered Red Lobster and was able to successfully purchase a Bud Light for \$5.81. The CI's ID was checked but a purchase was still made as observed by audio/video recording. Once the transaction was complete, the CI exited the restaurant and described the offender (Taylor Mitchell) to detectives. The CI stated the offender was a white female, with pink hair and tattoos on both arms. The receipt also reflected the name Taylor M.

After speaking with the CI and gathering all information, Detective Hoppe and I entered the establishment and made contact with Taylor. Taylor was subsequently issued a misdemeanor citation for violation of TCA 57-5-301, Sales to minors or intoxicated persons prohibited. Her court date was set for Monday, August 19th, 2024, in Wilson County General Sessions Court. I advised Taylor of the court process and she stated she understood.
